The objective of the project is to increase the job opportunity and skill development through use of Information and Communication Technology(ICT) which plays a pivotal role for instituting effective e-Governance, and essentially bridges the gap between government and citizens. Lower qualified youths are captured online through this system, imparted skill development training and suitably absorbed by job providers is the basic motto of this project.

With National Informatics Centre(NIC) as Knowledge Partner, this initiative is taken up by Government of Odisha to bring transparency in processes involved in Employment Mission activities and to prevent leakage of public money in form of reimbursement for fake candidate's training and their placement.

Features:**PIA(Training Providers)**

1. PIA can register themselves on line and get approved by OSEM for training and placement activities.
2. PIA can mobilize candidates from far off villages and later on can register those candidate through the system .
3. PIA can notify candidate/Training Centre or other individual through mail/SMS integrated with system
4. Various PIA centric report facilities like Training Centre-wise report, Batch wise report, Placement report etc. can be generated.
5. PIA can register online and update their profile at any point of time

Citizen/Job seekers

1. Job seeker can get information of various training programme available and other related information from the website.
2. Job seeker can register online by his/her own or can contact DEO/PIA concerned.
3. Once candidate is registered online, he/she will be notified through SMS/eMail alert for any batch creation in applied training centre and trade, making candidate up-to-date. This will prevent any possible discrimination by PIA.
4. Mission statistics can be viewed by anyone online.
5. Job seeker will be able to modify his/her preferences
6. After registration, a SMS/email Alert would be sent to the job seeker

OSEM and DEO:

1. Check spurious and duplicate candidates and hence can help in saving a lot of public money.
2. Makes Mission monitoring on finger tips through online monitoring system.
3. OSEM can send notification through mail/SMS integrated with system to all stakeholders
4. Brings transparency into the system by publishing the activities taken by OSEM dynamically
5. Facilitates various kinds of reports which further helps Government in monitoring and answering questions asked in Assembly and RTI

Assessing Bodies:

1. Registration of Assessing Bodies (ABs) to the system recognized by Ministry of Labour and Employment, GOI.
2. AB will be assigned the job of assessment on their expertise with a list of empanelled Verified Training Partner (VTP) to conduct testing. The ABs can download the candidate's data from the portal.
3. The MIS related to assessing will be available to OSEM, PIAs, ABs
4. Apart from the above OSEM will be provided the interface to add/update the VTPs against the trade district wise

5. OSEM will be provided the interface to update the control parameter for maximum number of batch to be allotted to an AB.
6. Based upon the assessment report the PIA will be reimbursed their Training and other consequent expenditure.
